## **Summary of meeting outcomes**

## **Final Meeting of Current Committee**

The February 2019 meeting of the NSW Shellfish Committee was the final meeting of the current committee. NSW Department of Primary Industries wishes to thank the industry members who have represented the industry admirably and achieved numerous outcomes to streamline processes, strengthen industry connections and contribute to legislation and policy amendments. A call for expressions of interest to be a part of the Shellfish Committee for the next term has been completed with the 8 May 2019 meeting being the first meeting of the new committee.

#### **Best Practice for Forestry Industry**

Following the November 2018 Shellfish Committee meeting acting CEO of the NSW Food Authority Eric Davis contacted Nick Melham (Group Director Forestry) to discuss logging run-off impacting receiving waters and possibly shellfish growing areas. #### **Shoalhaven River Cattle Impacting Water Quality**

Following the November 2018 Shellfish Committee meeting a letter regarding cattle access to riparian zones impacting water quality was provided to the Shoalhaven City Council in support of a trial in the local area. ### **Oyster Industry Strategy Update**

An implementation group of 10 NSW oyster farmers was created in 2015 to progress the priorities identified in the NSW Oyster Industry Strategy 2015. They provided a scoping paper to Shellfish Committee to consider permits/licences/lease tenure/security bond/entry level knowledge and exclusive possession of leases. DPI have engaged a senior analyst to review current NSW legislation associated polices and fees charged. The work will also consider the status of these issues in other Australian states.

#### **Aquaculture Production Report**

NSW DPI Fisheries Aquaculture Administration has released the 2017/18 Aquaculture Production Report. Oyster production has continued to increase in value and production. A copy of the 2017/18 Aquaculture Production Report can be located here.
